# Anthropological Thinking and Practice COURSE OUTLINE Fall 2020

**Mode of delivery:** For 2020/2021 this course will be conducted online, synchronously, using Zoom videoconferencing technology, with discussions to take place weekly during the scheduled synchronous class time. Additional course content will be made available to students through the course's OWL site.

**Synchronous class time:** Tuesdays 2:30 p.m. -- 4:30 p.m. EST.

Credit value: 0.5 credit

**Calendar Course Description:** This course explores current anthropological debates, trends in anthropological practice, and contemporary theoretical frameworks that inform the ways in which anthropology is applied within and outside of universities.

**Antirequisites:** The former Anthropology 4400E.

**Prerequisites:** Anthropology 3350F (or the former Anthropology 3301E), and registration in Year 4 in any Anthropology module.

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. The decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

#### **Course Syllabus:**

This course will be taught for the first time under the unusual circumstances of the 2020-21 academic year. We will meet weekly for synchronous sessions, doing what we can to manage the limitations and make the most of the possibilities that come with this format.

This course is intended to serve as a "capstone" course – meaning that it is intended to (1) encourage students to reflect on and draw from what they have learned through several years of studying anthropology while (2) giving them the opportunity to engage in original "anthropological practice" at an advanced level and in ways that are directed toward a variety of possible futures.

- reflect critically on the learning outcomes of the anthropology modules in which they are enrolled, and demonstrate how they have achieved these outcomes.
- communicate the importance of anthropology and the value of their own anthropological training to various audiences.
- evaluate the possibilities and limitations of "group work", and plan and carry out effective collaborations.
- effectively communicate their own anthropological passions to various audiences.
- better apply anthropological approaches and insights to a range of topics and experiences.

\*Work marked with an asterisk is required but will not be graded. Instead, students who complete this work will be acknowledged as having done so, and at the end of the course will receive a percentage grade on this work that is equivalent to the total grade attributed to their evaluated work in the course. For example, a student who receives a final grade on evaluated work of 80% will receive an 4/5 on their "Personal Statement Assignment".

Whenever students take an idea from another author, they must acknowledge their debt both by using quotation marks where appropriate and by proper referencing. # **Course Specific Conditions Required to Pass this Course**

In order to pass an essay course, the student must exhibit some minimal level of competence in essay writing and the appropriate level of knowledge of the content of the course.

#### **Academic Consideration for Student Absence**

Students will have up to two (2) opportunities during the regular academic year to use an online portal to self-report an absence during the term, provided the following conditions are met: the absence is no more than 48 hours in duration, and the assessment for which consideration is being sought is worth 30% or less of the student's final grade. Students are expected to contact their instructors within 24 hours of the end of the period of the self-reported absence, unless noted on the syllabus. Students are not able to use the self-reporting option in the following circumstances:

- for exams scheduled by the Office of the Registrar (e.g., December and April exams)
- absence of a duration greater than 48 hours,
- assessments worth more than 30% of the student's final grade,
- if a student has already used the self-reporting portal twice during the academic year

If the conditions for a Self-Reported Absence are *not* met, students will need to provide a Student Medical Certificate if the absence is medical, or provide appropriate documentation if there are compassionate grounds for the absence in question. Students are encouraged to contact their Faculty academic counselling office to obtain more information about the relevant documentation.

Students should also note that individual instructors are not permitted to receive documentation directly from a student, whether in support of an application for consideration on medical grounds, or for other reasons. All documentation required for absences that are not covered by the Self-Reported Absence Policy must be submitted to the Academic Counselling office of a student's Home Faculty.
